Data privacy statement

prevention-center AG exclusively collects, processes (and in particular stores) and uses the Customer's personal data for the purpose of performing the planned operation or the required procedure (operation). By signing this data privacy statement, the Customer consents to their data being used as detailed above.

1. Purpose and scope of application

This data privacy statement is an appendix to the GTCs of prevention-center AG; it describes how prevention-center AG handles personal data and serves to provide transparency for Customers.

2. Data processing principles

In the context of personal data processing (including the procurement, storage, use, disclosure, archiving and destruction of such data), prevention-center AG observes the following principles.

- a) The principle of proportionality and data economy; for example, Customers' personal data will only be disclosed to the doctor assigned to perform their treatment.
- b) prevention-center AG will not disclose or make third parties aware of Customers' personal data without authorisation.
- c) Personal data will only be processed for the purposes specified upon its collection, that were evident from the circumstances, or are legally mandated.
- d) Personal data will only be disclosed in accordance with this data privacy statement.
- e) Individuals whose personal data is processed by prevention-center AG can assert their legal right of access and right to rectification.

3. Categories and processing of personal data

The following is a list of the personal data that prevention-center AG processes in the course of rendering services:

- Name, address, date of birth, gender, telephone number and email, plus credit card and account details for billing purposes
- Customer health data, medical records provided by the Customer, X-rays, etc.
- Service-related data, contracts, billing data
- Data regarding past contact and correspondence with the Customer
- Health-related data for the purposes of quality assurance and continuous service development

4. Protection of personal data

prevention-center AG puts in place all organisational and technical measures to protect personal data as required by Swiss data protection law. This provides protection against the following risks in particular:

- a) unauthorised and accidental destruction or loss of data;
- c) technical faults;
- d) forgery, theft and illegal use of data;
- e) unauthorised editing, copying, access and other unauthorised processing.

These protective measures are constantly updated in accordance with the latest technical developments.

5. Right to object and right of access

prevention-center AG may only use the aforementioned data in the context of the consent issued herein.

The Customer has the right to access, rectify, block and delete their stored data free of charge, provided that no statutory retention periods prevent this. In particular, the Customer is entitled to:

- a) find out whether prevention-center AG is processing data pertaining to them;
- b) request that prevention-center AG provides a copy of the data pertaining to them, and
- c) instruct prevention-center AG to rectify inaccurate personal data.

6. Data transfer over the internet; transmission of data using mobile telephones/smartphones

As already stated in this data privacy statement, prevention-center AG implements the most stringent technical and organisational security measures to protect the personal data of its Customers. Given that Customers transfer data over the internet and upload it to the server of prevention-center AG, it is important to note that every data transfer over the internet is subject to inherent risks, such as being accessed by unauthorised third parties. This can lead to the transferred information being revealed or its content being changed and can also result in technical faults. Even if the sender and recipient are in the same country, it is not possible to exclude the possibility that data transferred over the internet will leave that country and be forwarded to a country in which less stringent data protection regulations are in force. prevention-center AG is unable to control the general risks inherent in each data transfer over the internet. Customers must bear in mind that prevention-center AG is not responsible or liable for the security of user data transferred to prevention-center AG over the internet. The Customer communicates in this way at their own risk. The Customer is hereby expressly made aware that observance of data protection regulations and data security cannot be ensured when sending messages or data with a mobile telephone or smartphone via SMS or WhatsApp (or another comparable messenger servers) to prevention-center AG. When transmitted in this way, data is not uploaded to the server of prevention-center AG equipped with the requisite security measures. Therefore, if Customers send data in this manner, they do so at their own risk; prevention-center AG expressly rejects any and all liability in relation to any form of privacy breach.

The Customer hereby consents to the data required for billing purposes being disclosed to the billing institution as well as to any debt collection company engaged by prevention-center AG, any solicitors engaged in such matters, and to the relevant government bodies.
